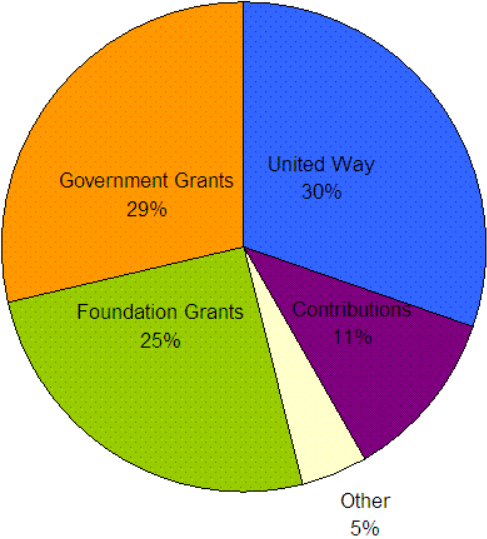

2008 Revenue

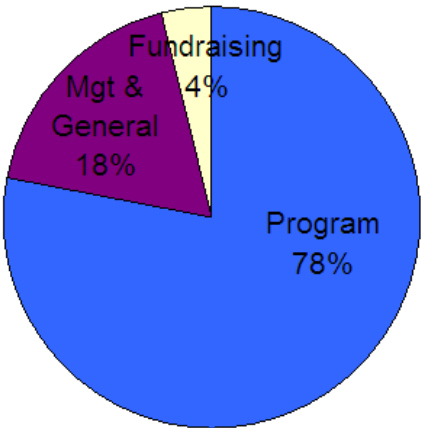
